BOARD RESOLUTION NO. 2016-05 By Referendum

APPROVING THE DEVELOPMENT ACADEMY OF THE PHILIPPINES CY2016 CORPORATE OPERATING BUDGET AND CY2016 CAPITAL EXPENDITURE BUDGET

WHEREAS, the DAP Management approved and adopted the Indicative CY2016 Corporate Operating Budget and the Indicative CY2016 Capital Expenditure Budget at the May 05, 2015 Board of Trustees meeting:

WHEREAS, the untimely demise of the Chairman of the Board of Trustees and the recently concluded election leads to a transition period that left a void in the leadership of the Board and consequently no board meeting was convened since then;

WHEREAS, the Board of Trustees recognized the urgent need for the DAP to have a Board Approved CY2016 Corporate Operating Budget and CY2016 Capital Expenditure for it to comply with the DBM reportorial requirements for the major government projects for CY2016;

WHEREAS, the Approved CY2016 Corporate Operating Budget and CY2016 Capital Expenditure Budget is required to be submitted to DBM in order for funds of the major government projects for CY2016 can be released and implemented by the DAP:

WHEREAS, the Board of Trustees agreed to approve by referendum the CY2016 Corporate Operating Budget and the CY2016 Capital Expenditure Budget;

NOW, THEREFORE, BE IT RESOLVED, as it is HEREBY RESOLVED, in view of the foregoing premises, the DAP Board of Trustees hereby approves the CY2016 Corporate Operating Budget in the amount of P873.403 Million inclusive of the CY2016 Capital Expenditure and Research & Development Budget in the amount of P96.386 Million. The details of the CY2016 Corporate Operating Budget and CY2016 Capital Expenditure Budget are shown in the "Summary of Proposed Corporate Operating Budget CY2016" (herewith attached as Annex A).

RESOLVED FINALLY, that this Resolution shall take effect immediately upon the approval and signature of a majority of the members of the Board of Trustees.
