This has reference to the discussions and agreements made during the Pre-Bid Conference conducted on 24July2012 (Tue) at the Board Room of the **dap** Bldg in San Miguel Ave., Pasig City by the Bids and Awards Committee (BAC) for the procurement of “**Supply of Any Unit or Six (6) Units Brand New Motor Vehicles**”. The following are being considered clarifications and/or modifications of the Official Bidding Documents (OBD):

I. Page 34, ITB Clause No. 18.1, Section III. Bid Data Sheet of the OBD. This shall be read:
