



Invitation to Bid

for the

“Supply, Installation and Commissioning of Brand New Audio Visual Equipment & Accessories at Floor 3B Classrooms of **dap Building in Pasig City”**

1. The **development academy of the philippines (dap)**, through the Capital Expenditures (CAPEX) of Corporate Fund for CY 2012 intends to apply the sum of ONE MILLION TWO HUNDRED PESOS (P1,200,000.⁰⁰) being the Approved Budget for the Contract (ABC) to payments under the contract for “Supply and Installation of Brand New Audio Visual Equipment & Accessories at Floor 3B Classrooms of **dap** Building in Pasig City” per IB No. B13-354397-02. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **dap** now invites bids for “Supply, Installation and Commissioning of Brand New Audio Video Equipment & Accessories at Floor 3B Classrooms of **dap** Building in Pasig City”. Delivery of the Goods is required Sixty (60) calendar days after receipt of Notice to Proceed (NTP). Bidders should have completed, within the last two (2) years prior to the deadline for the submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Official Bidding Documents (OBD), particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested bidders may obtain further information from DAP-BAC Secretariat and **inspect the Bidding Documents at the address given below starting June 11, 2013 (Tue) from 9:00AM to 5:00PM.**

A complete set of Official Bidding Documents may be purchased by interested Bidders starting **June 11, 2013 (Tue)** from the address below and upon payment of a **non-refundable fee for the Bidding Documents in the amount of ONE THOUSAND PESOS (P1,000.⁰⁰)**. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.

5. The **dap** will hold a **Pre-Bid Conference on June 18, 2013 (Thu) at 10:00AM** at **dap** Pasig City, which shall be open only to all interested parties who have purchased the Bidding Documents.
6. **Bids must be delivered to the address below on or before on July 3, 2013 (Wed) at 10:00AM.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on July 3, 2013 (Wed) at 10:00AM at dap Pasig City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
7. The **dap** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
