



Invitation to Bid for the

“One (1) Lot Supply, Installation and Commissioning of Airconditioning Units at 5B Floor in DAP Building, Pasig City” with Approved Budget for the Contract of P1,200,000.⁰⁰ -2nd bidding

(IB No. 15-367113-03a)

1. The **development academy of the philippines (dap)**, through the Corporate Operating Budget Fund for CY 2015 intends to apply to payments under the contract for the **“One (1) Lot Supply, Installation and Commissioning of Airconditioning Units at 5B Floor in DAP Building, Pasig City”** with ABC of ONE MILLION TWO HUNDRED THOUSAND PESOS (P1,200,000.⁰⁰) per Invitation to Bid (IB) No. **15-367113-03a**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **dap** now invites bids for the **“One (1) Lot Supply, Installation and Commissioning of Airconditioning Units at 5B Floor in DAP Building, Pasig City”**. **Delivery, Installation and Commissioning of the Goods is required –Thirty (30) days after the receipt of Notice to Proceed (NTP)**. Bidders must have all ongoing and completed government and private similar contract within the last two (2) years, whenever applicable prior to the date of submission and receipt of bids. The description of an eligible bidder is contained in the Official Bidding Documents (OBD), particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested bidders may obtain further information from DAP-BAC Secretariat and inspect the Bidding Documents at the address given below starting **October 02, 2015 (Friday)** from 9:00AM to 5:00PM.

A complete set of Official Bidding Documents may be purchased by interested Bidders starting **October 02, 2015 (Friday)** from the address below and upon payment of a **nonrefundable fee for the Bidding Documents in the amount of FIVE THOUSAND PESOS ONLY (P5,000.⁰⁰)**. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of **dap**. Bidders intending to join shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

5. The **dap** will hold a Pre-Bid Conference on **October 09, 2015 (Friday)** at 10:00AM at **dap** Pasig City, which shall be opened only to all interested parties who have purchased/paid the Bidding Documents.
6. Bids must be delivered to the address below on or before on **October 22, 2015 (Thursday)** at 10:00AM. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on **October 22, 2015 (Thursday)** at 10:00AM at **dap** Pasig City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

7. The **dap** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
