



Invitation to Bid

“One (1) Lot Supply of Supervision, Labor, Materials, and other Consumables for the Repainting of DAP Building Facades/Exterior Wall with Approximate Area of 6,250 square meter”
with Approved Budget for the Contract of P2.2M
(Invitation to Bid No. IB16-375937-08)

1. The development academy of the philippines (dap), through the Corporate Operating Budget Fund for CY 2016 intends to apply to payments under the contract for the “One (1) Lot Supply of Supervision, Labor, Materials, and other Consumables for the Repainting of DAP Building Facades/Exterior Wall with Approximate Area of 6,250 square meter” with ABC of TWO MILLION TWO HUNDRED THOUSAND PESOS (P2,200,000.⁰⁰) per Invitation to Bid (IB) No. IB16-375937-08. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The dap now invites bids for the “One (1) Lot Supply of Supervision, Labor, Materials, and other Consumables for the Repainting of DAP Building Facades/Exterior Wall with Approximate Area of 6,250 square meter”. Supply of Supervision, Labor, Materials, and other Consumables for the Repainting of DAP Building Facades/Exterior Wall is required –Ninety (90) calendar days after the receipt of Notice to Proceed (NTP). Bidders should have all its ongoing government and private contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid; and should have completed at least two (2) similar contracts and the aggregate contract amounts should be equivalent to at least the percentage of the ABC and the largest of these similar contracts must be equivalent to at least half of the percentage of the ABC to the contract to be bid, within the last two (2) years prior to the date of submission and receipt of bids. The description of an eligible bidder is contained in the Official Bidding Documents (OBD), particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of

which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

- Interested bidders may obtain further information from DAP-BAC Secretariat and inspect the Bidding Documents at the address given below starting **November 29, 2016 (Tuesday)** from 9:00AM to 5:00PM.

A complete set of Official Bidding Documents may be purchased by interested Bidders starting **November 29, 2016 (Tuesday)** from the address below and upon payment of a **nonrefundable fee for the Bidding Documents in the amount of TWO THOUSAND PESOS ONLY (P2,000.⁰⁰)**. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of **dap**. Bidders intending to join shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

- The **dap** will hold a Pre-Bid Conference on **December 12, 2016 (Monday)** at 10:00AM at **dap** Pasig City, which shall be opened only to all interested parties who have purchased/paid the Bidding Documents.
- Bids must be delivered to the address below on or before on **January 05, 2017 (Thursday)** at 10:00AM. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on **January 05, 2017 (Thursday)** at 10:00AM at **dap** Pasig City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- The **dap** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
