1. The development academy of the philippines (dap), through the General Appropriation Act of FY2018 intends to apply the sum of **FOUR MILLION PESOS (P4,000,000.⁰⁰)** being the Approved Budget for the Contract (ABC) to payments under the contract for **“ONE LOT (1) REPAIR/ REHAB/ RENOVATE / REFURBISH / RESTORE OF EXISTING COTTAGES IN DAPCC TAGAYTAY INCLUSIVE OF DESIGN, MATERIALS, EQUIPMENT, TOOLS, LABOR, AND SUPPLY & INSTALLATION OF FIT-OUTS”** with IB No. IB18-387299-07. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The development academy of the philippines (dap) now invites bids for **“ONE LOT (1) REPAIR/ REHAB/ RENOVATE / REFURBISH / RESTORE OF EXISTING COTTAGES IN DAPCC TAGAYTAY INCLUSIVE OF DESIGN, MATERIALS, EQUIPMENT, TOOLS, LABOR, AND SUPPLY & INSTALLATION OF FIT-OUTS”**. Completion of the Works is required within **One Hundred Twenty (120)** calendar days from the receipt of Notice-to-Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. INSTRUCTIONS TO BIDDERS.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA9184), otherwise known as the “Government Procurement Reform Act.” Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock to citizens of the Philippines.
4. Interested bidders may obtain further information from the **dap-BAC** Secretariat and inspect the Official Bidding Documents (OBD) at the address given below starting on **11 October 2018 (Thu)** to **05 November 2018 (Mon)** from **9:00AM** to **5:00PM**.
5. A complete set of the **Official Bidding Documents (OBD)** may be acquired by interested bidders on **11 October 2018 (Thu)** to **05 November 2018 (Mon)** from **9:00AM** to

5:00PM from the address below and upon payment of the non-refundable applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **FIVE THOUSAND PESOS (P5,000.⁰⁰)**.

6. The information on the bidding documents may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
7. The **Dap** will hold a **Pre-Bid Conference on 19 October 2018 (Fri), 10:00AM** at **DAP Conference Center in Tagaytay City**. This will be open to prospective Bidders.
8. Bids must be duly received by the BAC Secretariat at the address below on or before **05 November 2018 (Mon) at 10:00AM**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.
9. Bid opening shall be on **05 November 2018 (Mon) at 10:00AM** at **DAP Conference Center, Tagaytay City**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. **LATE BIDS SHALL NOT BE ACCEPTED**.
10. **The Dap reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected Bidder or Bidders.**
