1. The **development academy of the philippines (dap)**, through the Corporate Operating Budget Fund for CY2019 intends to apply the sum of **NINE MILLION SEVEN HUNDRED THOUSAND PESOS (P9,700,000.<sup>00</sup>)** with **Invitation to Bid No. IB19-389530-03** being the Approved Budget for the Contract (ABC) to payments under the contract for **“ONE (1) LOT RE-WATERPROOFING OF ROOF DECKS OF MAIN BUILDING AT DAP CONFERENCE CENTER – TAGAYTAY CITY”**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **development academy of the philippines (dap)** now invites bids for **“ONE (1) LOT RE-WATERPROOFING OF ROOF DECKS OF MAIN BUILDING AT DAP CONFERENCE CENTER – TAGAYTAY CITY”**. Completion of the Works is required within **Sixty (60)** calendar days from the receipt of Notice-to-Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. INSTRUCTIONS TO BIDDERS.

Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA9184), otherwise known as the “Government Procurement Reform Act.” Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock to citizens of the Philippines.
4. Interested bidders may obtain further information from **development academy of the philippines (dap)** and inspect the Official Bidding Documents (OBD) at the address given below starting on **March 27, 2019 (Wed)** from **09:00AM to 4:30PM**.
