



## INVITATION TO BID

1. The **development academy of the philippines (dap)**, intends to apply the sum of **NINE MILLION SEVEN HUNDRED THOUSAND PESOS (P9,700,000.<sup>00</sup>)** being the total Approved Budget for the Contract (ABC) for the procurement of each lot as follows:

2. Bids received in excess the stated amount of ABC shall be automatically rejected at bid opening.

The **dap** now invites interested Bidders to apply for eligibility and to bid for the procurement of **“ONE (1) LOT REPAIR/ REHABILITATION/ RESTORATION/ REFURBISHING (“COTTAGES-4R”) OF EXISTING COTTAGES ENCLAVE”** and **“ONE (1) LOT DISPOSAL OF THREE (3) UNITS TRANSFORMERS”** at the **DAP Conference Center in Tagaytay City**.
4. The completion of the Works shall be in accordance with the delivery schedule under Section VI - Schedule of Requirements and Specifications.
5. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. INSTRUCTIONS TO BIDDERS. Bidders should have completed similar contracts amounting to at least fifty percent (50%) of ABC of the specified lot/s to be bid. **Bidders may participate in any one or both Lots (Lot 1 and Lot 2).**
6. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA9184), otherwise known as the “Government Procurement Reform Act.” Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy-five percent (75%) interest or outstanding capital stock to citizens of the Philippines.
7. A complete set of **Official Bidding Documents (OBD)** may be acquired by interested Bidders on **02 August 2019 (Fri) to 23 August 2019 (Fri)** from **09:00AM to 4:30PM** from the address below and upon payment of the non-refundable applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, the cost for the Official Bidding Documents is **SEVEN THOUSAND PESOS (P7,000.00)**.
