



**INVITATION TO BID
FOR**

**“ONE (1) LOT SUPPLY OF FOUR (4) UNITS BRAND NEW MOTOR VEHICLES IN
DAP MAIN BUILDING, PASIG CITY”

1. The **Development Academy of the Philippines (DAP)**, through the Capital Expenditures (CAPEX) of Corporate Fund for CY 2019 intends to apply the sum of **EIGHT MILLION NINE HUNDRED NINETY SEVEN THOUSAND PESOS (P8,997,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **“ONE (1) LOT SUPPLY OF FOUR (4) UNITS BRAND NEW MOTOR VEHICLES IN DAP MAIN BUILDING, PASIG CITY” per IB No. 19-393946-09**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **DAP**, now invites bids for **“ONE (1) LOT SUPPLY OF FOUR (4) UNITS BRAND NEW MOTOR VEHICLES IN DAP MAIN BUILDING, PASIG CITY”** Delivery of the Goods is required within **One Hundred Twenty (120) calendar days after the receipt of Notice to Proceed (NTP)**. Bidders should have all their ongoing government and private contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid; and single largest completed contract similar to the contract with at least 50% of the ABC to be bid, within the last three (3) years prior to the date of submission and receipt of bids. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information from the **Development Academy of the Philippines (DAP)** and inspect the Official Bidding Documents (OBD) at the address given below starting **29 November 2019 (Fri)** from **9:00AM to 5:00PM**.
5. A complete set of Official Bidding Documents may be acquired by interested Bidders on **29 November 2019 (Fri)** from the address below and upon payment of a **non-refundable fee for the Bidding Documents in the amount of SIX THOUSAND PESOS ONLY (P6,000.⁰⁰)**. Per appendix 8 of RA9184.

6. The **DAP** will hold a Pre-Bid Conference on **12 December 2019 (Thu)** at **10:00AM** at **DAP Pasig City**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **07 January 2020 (Tue)** at **10:00AM** .All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18. Late bids shall not be accepted.

Bid opening shall be on **07 January 2020 (Tue)** at **10:00AM** at **DAP Pasig City**. Bids will be opened in the presence of the bidders’ representatives who choose to attend at the address below.
8. The **DAP** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
