BAC RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD OF CONTRACT TO KERGIE ENTERPRISES

WHEREAS, on Nov.22, 2019 (Fri), the Bids and Awards Committee 1 (BAC1) issued a BAC Resolution No.035, s.2019¹ declaring KERGIE ENTERPRISES as the Single Calculated Bid (SCB) for the above-named Project;

WHEREAS, on Nov.26, 2019 (Tue), the BAC1-Technical Working Group (BAC1-TWG) Members for the Project conducted a Post-Qualification assessment of the submitted bid by KERGIE ENTERPRISES to determine its "responsiveness";

WHEREAS, a Memorandum² dated Nov.26, 2019 (Tue) addressed to the BAC Chairperson signed by the BAC-TWG Chairperson, recommended to declare the bid submitted by KERGIE ENTERPRISES as the Single Calculated and Responsive Bid (SCRB);

NOW, THEREFORE, be it RESOLVED, as it is hereby RESOLVED,

- 01. That the bid submitted by KERGIE ENTERPRISES be declared as the Single Calculated and Responsive Proposal (SCRP) in consideration of its total amount of SEVEN MILLION SEVENTY FOUR THOUSAND TWENTY TWO PESOS AND 20/100 (P7,074,022.20/100);³;
02. That, we, the members of the Bids & Awards Committee (BAC), as per Special Order No.2018-119 & SO No.2019-074A, recommends to the Head of the Procuring Entity (HoPE) per GCG MC No.2012-07 dated November 28, 2012, the approval of this BAC Resolution; and
03. That, a Notice of Award (NOA) be issued to KERGIE ENTERPRISES upon adoption and approval of this BAC Resolution.
